**Annual Reporting Year:** 2021

**Background:** Cook County and participating municipalities in the county developed a hazard mitigation plan to reduce risk from all hazards by identifying resources, information, and strategies for risk reduction. The federal Disaster Mitigation Act of 2000 requires state and local governments to develop hazard mitigation plans as a condition for federal disaster grant assistance. To prepare the plan, the participating partners organized resources, assessed risks from natural hazards within the county, developed planning goals and objectives, reviewed mitigation alternatives, and developed an action plan to address probable impacts from natural hazards. By completing this process, these jurisdictions maintained compliance with the Disaster Mitigation Act, achieving eligibility for mitigation grant funding opportunities afforded under the Robert T. Stafford Act.

**Purpose:** The purpose of this report is to provide an annual update on the implementation of the action plan identified in the Cook County Multi-Jurisdictional Hazard Mitigation Plan. The objective is to ensure that there is a continuing and responsive planning process that will keep the Hazard Mitigation Plan dynamic and responsive to the needs and capabilities of the partner jurisdictions. This report discusses the following:

- Natural hazard events that have occurred within the last year
- Changes in risk exposure within the planning area (all of Cook County) Mitigation success stories
- Review of the action plan
- Changes in capabilities that could impact plan implementation

## Hazard Analysis

Hazards that represent a county-wide risk are addressed in the Risk Assessment section of the 2019 Cook County Multi-Jurisdictional Hazard Mitigation Plan Update. This section only addresses the hazards and their associated impacts that are **relevant** and **unique** to the municipality.

**Severe Weather:** In 2003, several trees, large tree limbs and power lines were blown due to severe thunderstorms and wind gusts. The large tree limbs also resulted in a house being damaged.

**Flooding:** As recent (2019) the northwest segment of town area is in flood condition and has previously flooded the last 12 months. Residential area with school, police, and fire departments HQs impacted. Flood mitigation/drainage northwest segment of town.
